






Notice to reader

Shakti Network will be a decentralized network, anticipated to be distributed evenly across the globe in proportion to the relative size of the local population. 
MINERS

Earning potential for Mining License holders

Miners earn fees for validating transactions by installing SXE mining servers on the Shakti Network. For that service, miners earn fixed transaction fees.

A BIT OF THE TECHY STUFF

• Miners share a fixed transaction processing fee, and it is paid in Toshi – a micro denomination of SXE.

• First, the miner who initiates the consensus earns 5% of the

• Second, the set of miners who confirm the consensus earns 85% of the transaction fees at the rate of 5 Toshi (0.00005 SXE or US 0.025 c), until the sum of the fees earned reaches 90% of the total.

• Finally, the remainder of the 10% of total fees is paid to the SXE Network to enforce Global Compliance and Shakti Network Monetary Protocol (SNMP) Policy and continue to further propagate the SXE monetary policy and promote Shakti Coin adoption globally.

• Any payment up to and including two (2) Shakti Coins is considered a micro-transaction. The Transaction processing cost for any micro-transaction is fixed at 500 Toshi (= US 2.5¢).

SOFTWARE REQUIREMENTS

The first release of the Shakti Mining application will support the following OS:

Windows: 64-bit Windows 10 Or 11. Ubuntu: 64-bit Ubuntu 20.04.

Other Linux Distribution such as Debian, Red Hat, CentOS, Mint and other popular OS in due course.

Minimum: A dual-core Intel/AMD based system 1.2GHz with 2GB RAM and 500GB of storage.

Recommendation: A quad-core or greater Intel/AMD based system at 3.5GHz with 6GB RAM and 2TB of storage.

The Mining application may be provided for non-Intel/AMD platforms running a supported version of Linux at a later date. The hardware requirements may vary from the Intel/AMD specs mentioned.
